

UNAIDS STRATEGY: GETTING TO ZERO



UNAIDS work on gender is guided by two Goals:

•Gender transformative HIV responses that bring about equality and social change.

•Zero tolerance for violence against Women and Girls.




UNAIDS, HIV, AND GENDER INEQUALITIES

- UNAIDS is committed to advancing gender equality for an effective HIV response, and calling for gender-transformative HIV responses.
 - UNAIDS calls for HIV responses that foster social transformation to deal with those social norms and practices fuelling gender inequalities and gender-based violence.
- 2011 Political Declaration on HIV/AIDS set the elimination of gender inequalities and gender-based violence as one of its ten targets.
 - UNAIDS action in this area is set out in the Agenda for Women and Girls and the 'Getting to Zero' Strategy.



UNAIDS AGENDA FOR WOMEN AND GIRLS



The Agenda:

- •Provides a menu of strategic actions.
- •Supports countries in moving towards gender-transformative HIV responses.
- •Operationalized in over 100 countries to date.
- •Civil society is a key partnering constituency.



GENDER FUNDING OPPORTUNITIES

- The Global Fund is committed to addressing inequalities in health service, and to developing individual operational plans for women and key populations.
- The New Funding Model (NFM) includes opportunities both for gender-specific programming, and for mainstreaming gender across funding requests.
 - Intended to serve as a catalyst for a more gendertransformative HIV response.
 - Future grant submissions: evidence-driven programmes for these populations, rooted in respect for their human rights.



GENDER ASSESSMENT OPPORTUNITIES AND THE GLOBAL FUND

- First step of the NFM: a country-level review of the National Strategic Plan for HIV.
 - But: national strategic planning processes often lack essential information on the epidemic, context and response from a gender perspective.
 - This makes the identification of gender gaps, policy recommendations, and grant proposals far more difficult.
 - Global Fund recommendation: national gender assessment of the HIV epidemic, context and response.

The UNAIDS Gender Assessment Tool fulfills this function.



WHY A GENDER ASSESMENT TOOL?

- National planning and budgeting processes are not gender sensitive, as revealed by:
 - The UNAIDS Scorecard on Gender Equality within HIV Responses
 - Global Fund grants
 - Knowledge gaps on gender issues impede both 'knowing your epidemic' and 'knowing your response'.
 - The UNAIDS tool allows countries to review their HIV epidemic, context and response from a gender



THE GENDER ASSESMENT TOOL

The tool:

- Aims to inform the national strategic planning process.
- Supports countries to position gender equality, SRHR, and GBV in the "strategic investment" discussion.
- Builds on already available information, to allow flexibility as per local context.
- Uses questions to identify remaining gaps in information.
- Was developed by UNAIDS Secretariat, with cosponsors, governments, civil society, and development partners.





FEEDING INTO THE FUNDING MECHANISM :

- Intended to connect to the following national strategic opportunities and funding processes:
 - ✓ Development or mid-term review of the national strategic plan;
 - Country Coordinating Mechanism discussions in preparation for a Global Fund request;
 - Concept Note: ensuring the including and prioritization of gender-related activities;
 - ✓ Reference material for an eventual Global Fund Technical Review Panel;
 - Securing high-level political commitment towards greater
 attention to gender in the national HIV response.
 Zero discrimination.
 Zero AIDS-related deaths.

THE VALUE OF THE TOOL

- Provides guidance for a more systematic and standardised gender analysis and planning of the HIV response.
 - Clear set of steps to examine and question the gendersensitivity of the HIV response.
- Allows stakeholders to learn about the extent to which the national response recognises and acts on gender inequality as a critical enabler of the HIV response.
- Supports countries in leveraging and mobilising resources (including those of the Global Fund) for gender programming.
 - Critical as one part of a wider HIV toolkit.






PART OF A COMPREHENSIVE APPROACH

- Critical element of a set of complementary tools:
 - Gender roadmap (UNDP) to advocate
 - *Gender Assessment Tool (UNAIDS)* to determine the gaps
 - What Works for Women to recommend effective actions
 - WHO to provide normative guidance
 - Compendium of gender indicators (UNW) to measure results
 - Investment approach to ensure value for money
 - Gender sensitive costing and budgeting (UNW/UNAIDS) –

STAGE 1: PREPARING FOR THE GENDER ASSESMENT OF THE NATIONAL HIV RESPONSE

National-Level Preparation includes:

✓ Securing high level commitment

✓ Establishing a country assessment team

✓ Collecting and collating relevant documents



STAGE 2: KNOWING THE HIV EPIDEMIC AND CONTEXT IN THE COUNTRY

Find relevant data disaggregated by sex, key populations, age if available:

- ✓HIV and AIDS prevalence and incidence
- ✓ Social, cultural and economic factors
- ✓Political and macro economic factors



STAGE 3: KNOWING THE COUNTRY HIV RESPONSE

Key areas to assess include:

- ✓Meaningful participation
- ✓HIV Prevention
- ✓Treatment
- ✓Care and Support
- ✓ Women and girls, key populations, men and masculinities, gender-based violence
- ✓ Sexuality, sexual and reproductive health and rights



STAGE 4: ANALYSING AND USING THE FINDINGS OF THE GENDER ASSESMENT FOR A TRANSFORMATIVE HIV RESPONSE

After the GAT Exercise:

✓Analyze and identify the gaps and opportunities

✓ Define priorities

✓Identify strategic interventions

✓ Develop an advocacy plan, communication strategy, and fundraising strategy
